

Terms and conditions – B2C Offer Online & In-Mall, at Maplevue Shopping Centre Only

Redemption: Electronic gift cards, along with electronic bonus cards must be transferred to plastic gift cards at the Guest Services of a participating Ivanhoé Cambridge shopping center, to be used at participating retailers. In order to redeem the e-code for a physical card, a government issued ID must match the name on the email with the e-code. Electronic bonus cards are transferred onto Reward cards. Electronic bonus cards can only be redeemed within the center where the cards were purchased.

Plastic shopping centre Gift Card terms and conditions differ, see [Cardholder Agreement](#) for more details. **Shopping Centre Gift Card** funds do not expire. **Reward Gift Card** funds expire 12 months from the card activation date.
